Sub: Provisional Up Gradation of School under Rule 52 of DSER, 1973 from Secondary to Senior Secondary Stage with effect from the academic session 2006-07 (without aid) in Humanities & Commerce and Science Stream.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education for up gradation of Ahlcon International school from Secondary to Senior Secondary level with humanities and Commerce Stream and Science Stream only without aid with effect from academic session 2006-07 subject to the fulfilment of the following terms and conditions: -

1. That the school shall abide by the provisions of Delhi School Education Act, 1973 and Rules framed there under as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall make the additional liability of Senior Secondary Classes.
4. That a proper library shall be established and facilities for reading and room shall also be made available for students as well as teachers. Books as per the ration of 10 books per students shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of Section 10(1) of the Delhi School Education Act/Rules 1973.
7. That the school shall not run un-recognized classes of any non-educational activities within the school premises and all the recognized classes shall be run at any place at the above address only. Nursery Classes be removed from the premises of the school immediately, if any.
8. That the school shall discontinue the services of unqualified and over-aged staff if any immediately.

The Management of the School will obtain land from the DDA, if already not obtained, in the name of the society through Director of Education, Delhi and shall construct a school building thereon for the school as per specification of the Department within the period of three years. The adequate and sufficient accommodation of 10 Sq. Ft. per student shall be provided for class-rooms. The normal size of the class room will be 15' X 20'.

That proper facility for drinking water, toilet and first aid to be provided. Separate toilets for boys/girls and separate toilets for ladies and gents staff be also provided.

That the Managing Committee of the school shall not increase/enhance fee during the ensuing academic session without prior approval of the Director of Education which is the mandatory requirements under sub-section (3) of Section 17 of Delhi School Education Act and Rules, 1973.

That all the facilities prescribed under rules 50 and 51 of DSER, 1973 shall be made available to the students.

That the Management of the school shall create a Reserve Fund to minimum three months salary of the staff in the joint name of Director of Education and Manager of the School.


That the school shall comply with the norms of the CBSE for affiliation fees/ examination purpose.

That management of the school will ensure admission of the weaker section of the society as per prescribed norms of the Directorate of Education.

A fresh health certificate is required to be submitted from the school within a month.

THAT THE SCHOOL AUTHORITY WILL SUBMIT (1) WATER TEST REPORT FROM THE COMPETENT AUTHORITY AND (2) NOC FROM THE CHIEF FIRE OFFICER BY 30.09.2007.


