
**Subject: Grant of Provisional Recognition under rule 52 of the Delhi School Education rules, 1973, from class I to X w.e.f. Academic session 2004 - 2005 (Without aid)**


Sir,

With reference to your application on the subject noted above I am directed to grant Provisional Recognition under rule 52 of the Delhi School Education rules, 1973, from class I to X w.e.f. Academic session 2004 - 2005 (Without aid) Subject to the condition that the school authorities would get formal approval of the Director of Education for age relaxation in respect of overage staff, as per rules on the subject, by 01.11.2004.

1. That the school shall abide by the provisions of Delhi School Education Act & Rules, 1973 framed there under as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of cast and creed and preference shall be given to the students of Mayur Vihar Area.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the department.
4. That the school shall equip the Science labs as per the norms of the department and suitable facilities for practical work shall be provided to the students. More material worth Rs. 5,000/- shall be purchased.
5. That the proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading-room may also be provided immediately and more books worth Rs. 5,000/- may be purchased by the start of the next session.
6. That adequate sports material shall be purchased and made available to the students immediately. More sports materials worth Rs. 3,000/- shall be purchased.

7. That the school shall strictly abide by the provisions of Delhi School Education Act & Rules, 1973 and payment shall be made as per section 10(1) of Delhi School Education Act, 1973 to all the employees.
8. That the enrolment in each section shall not exceed the number of students calculated @ 1 Dsq. ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of Directorate of Education, Delhi, in each class. Number of existing sections should not exceed the number of the classrooms of proper size in the school.
9. That the school shall not run any pre-primary and un-recognized classes or any other activities within the school premises and all the recognized classes shall be run at one place. Nursery classes be removed from the premises of the school, if any. No branch of the school shall be run under the banner of the recognized school.
10. That the school shall dispense with the services of unqualified and over age staff, if any, immediately.
11. That the service contract between the management and the employee shall be executed immediately.
12. That all the facilities prescribed under Rules 50 and 51 of DSER, 1973 shall be made available to the students. Provisions of Rules 6,7 and 9 be strictly observed.
13. That arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
14. That the management of the school shall create a Reserve Fund of Rs. 5,000/- (rupees five thousand) only in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
15. That the violation of any instructions/ orders/ conditions/ rules and regulations of the department shall lead to the withdrawal of the recognition of the school and class ~~ix~~ shall not be opened without the prior approval of the Director of Education, Delhi.
16. That school society shall apply for the allotment of the land and will construct the building as per the specification of the Directorate of Education, Delhi. and shall construct the building as per the specification of DDA.



17. That the management of the school shall provide all the facilities as per Rule 50 and all conditions as required under Rule 51 shall be complied with
18. That the report about the fulfillment of above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month
19. That the school authorities would get formal approval from Director Education for age relaxation in respect of overage staff as per rules on the subject by 01.11.2004
20. Since the provisional recognition is w.e.f. the academic session 2004 - 2005. The Director does not recognize the class VIII started by the school prior to the grant of this recognition. Therefore the school would take admission in class IX only in respect of students having passed class VIII from a recognized school.


